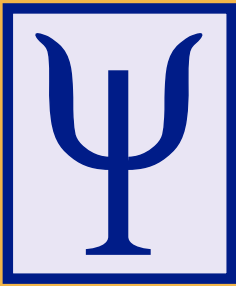

▶ **General Session – Neuroscientific Basis of Addiction, Recovery & Relapse**

BY DARRYL S INABA, PHARM.D., CADIC III, CATC-V

Research of the brain anomalies associated with addictive disorders provides an understanding of the differences between the wide variety of drugs and behavioral compulsions that can develop in some individuals predisposed to Substance-Related and Addictive Disorders. It also helps to explain why some are more likely than others to relapse during treatment of these chronic persistent medical disorders. The rapidly expanding field of Addiction Medicine targets brain anomalies of addiction with Medication Assisted Treatment (MAT) to promote better assessment, prevention and treatment tools for the better management of those struggling with the brain anomalies of addiction. Resiliency and plasticity of the brain manifests its amazing ability to regain functionality with continued sobriety during the recovery process.

This presentation will explore the neuroscientific basis of addiction, recovery and recrudescence to dispel the undue stigma associated with Substance Related and Addictive Disorders. It will share results of brain imaging and other research processes that validate past as well as recent developments in the effective management of this chronic persistent disorder.

*Dr. Darryl Inaba is Director of Clinical and Behavioral Health Services for the Addictions Recovery Center and Director of Research and Education of CNS Productions in Medford, Oregon. He is an associate Clinical Professor at the University of California in San Francisco, CA., and a Lifetime Fellow at Haight Ashbury Free Clinics, Inc., in San Francisco, CA. Dr. Inaba has authored several papers, award winning educational films, and is co-author of *Uppers, Downers, All Arounders* a text on addiction and related disorders that is used in more than 400 colleges and universities. He has been honored with more than 90 individual awards for his work in the areas of prevention and treatment of substance abuse problems. He is a popular speaker at workshops and conferences nationally and internationally.*

A2 Solving the Problem of Addiction

This presentation will also review the most common addictions, including both substance and behavioral, with an enhanced focus on opioids. Finally, Dr. Fitzgerald will wrap up by offering clear guidance on how to optimize addiction treatment.

In partnership with Dr. Paul Conti he co-founded HealthWorks NW, an innovative outpatient integrated treatment program and continued to work there after it was acquired by Hazelden.

D1 SMART Recovery: A Self-Empowering Addiction Recovery Option

BY HANK ROBB, PHD, ABPP

Individuals with problematic addictive behaviors (substances or activities) often benefit from mutual help groups. While 12-step groups are the most well-known and available, SMART Recovery, now twenty-five years old, has become the second most available - and foremost self-empowerment option with meetings in 23 countries - which includes a handbook translated into fourteen languages. SMART is now recognized as an important mutual help, self-empowerment, option by the National Institute for Drug Abuse, the National Institute for Alcohol Abuse and Alcoholism, the Substance Abuse and Mental Health Services Administration, and many other **US and international** institutions. This presentation will present the 4 Points of SMART Recovery; describe how both SMART meetings and Family & Friends meetings are established and maintained; cognitive-behavioral tools available through meetings; and research indicating the effectiveness of this mutual help approach.

D2 Psychopharmacology and Therapeutic Interventions for Pain, Pain-Related Addiction, and Mood Comorbidities

BY CARILYN ELLIS, PSYD; AND ERICH SCHMIDT, PHARM D

This session is led by a board certified pharmacist in psychopharmacology and a psychologist with a postdoctoral master in clinical psychopharmacology. We will cover common medications prescribed for pain, pain-related addiction, and mood, as well as comorbidities associated with pain (ex. sleep, anxiety). We will discuss some diagnostic considerations, the overall efficacy, impact, and side effects of various medications, as well as recommended concurrent psychological treatments and collaboration with medical and psychiatric prescribers.

D3 Adverse Childhood Experiences: Looking at Addiction Through a Trauma Informed Lens

BY AMY STOEBER, PHD

Dr. Stoeber has created a curriculum to mitigate the effects of trauma through resilience training for physicians and schools. Dr. Stoeber will review the ACEs study and the impact of early trauma, including addiction, on long term population health effects. She will also discuss how early trauma leads to chronic health problems as well as future addictive behavior. A focus on prevention and intervention will be key.
