


Substance Use Stigma: A Systematic Review of Measures & Their Psychometric Properties

INTRODUCTION

- > 50% of the United States population over the age of 12 has used illicit substances in their lifetime¹
- Substance Use Stigma (SUS): Discrimination and "othering" by a culture due to a person's drug use²
- SUS can pose as a barrier to substance use treatment
 - Inadequate support by healthcare systems, insensitive providers, & political efforts to block funding^{3,7}
- Tyes of SUS Stigma:
 - Structural Stigma: Policies, Institutions, and social structures²
 - Social Stigma: Public stereotyping, reactions, status loss²
 - Internalized or self-stigma: Attitudes & beliefs about oneself due to personal substance use⁵⁻⁷
- SUS measures haven't kept up with research on stigma effects. We aim to review psychometric properties of SUS measures and illuminate future directions for SUS researchers.

METHODS

Identify & Screen

- Adapted COSMIN guidelines
- Database (Psychlnfo, WebofScience & Pubmed) & Reference searches
- Screened a total of 221 articles, 17
 were included in review

Articles assessed for: Content validity,
 Structural validity, Internal Consistency,
 Measurement invariance, Test-retest
 reliability, Criterion validity, Convergent
 validity, Discriminative Validity,
 Responsiveness, Limitations

Substance Use Stigma Mechanisms Scale (SU-SMS) ²¹	Enacted, Anticipated, & Internalized Stigma	Content Validity, Internal Consistency, Structural Validity, Convergent Validity, Discriminant Validity

KEY TAKEAWAYS

- Total of 18 SUS measures with psychometric analyses
- 12 measures of social stigma, 9 measures of internalized stigma, 2 measures accounted for both internalized and social stigma
- There were 0 measures of structural stigma
- Most measures were adapted measures of mental illness stigma
- Psychometric analyses of Measurement Invariance critically needed
- Only the PSAS had more than one psychometric study

Measures of structural stigma need development



More psychometric studies are needed for all SUS measures
